Sgt. Neblock questioned the ability of the Trustees to obtain Fiduciary Liability insurance now that our assets exceed one million dollars. Mrs. Lyons advised the fund would need to be funded to a minimum 60% prior to being eligible for this type of insurance.

Discussion began regarding trustee elections which will be held in April and will now include Retired Beneficiaries. Sgt. Neblock asked if the Beneficiary Member position on the board would be filled by the two who have retired despite neither currently receiving benefits. Mrs. Goodloe advised they would still be considered for the Beneficiary Member position per Statute and will be entitled to a vote. Sgt. Neblock and Mrs. Lyons will work on a ballot for the Beneficiary Member and ensure they are included in the April vote. Mrs. Lyons will remind the Village President that Chip Hessenflow's term will expire May 1 and is eligible for reappointment by the Village President and approval of the Village Trustees

Mrs. Lyons has uploaded the Predatory Lending Certification form from First American Bank for 2015 to the Department of Insurance.

Trustees were reminded of the 16 hour annual requirements for training which needs to include 8 hours of ethics.
